## CRICUT® EVERYWHERE OFFICIAL RULES

"Cricut Everywhere Contest" with Kingston Crafts and Cricut® Official Rules (no purchase necessary). Sponsored by Provo Craft & Novelty, Inc., South Jordan, UT. Entries must be received by 11:59pm MDT May 11, 2015 (or as designated herein).
